

SECTION 5: Firefighting measures

Extinguishing media

Suitable extinguishing agents:

If in laboratory setting, follow laboratory fire suppression procedures. Use appropriate fire suppression agents for adjacent combustible materials or sources of ignition. Use water spray, alcohol-resistant foam, dry chemical or carbon dioxide.

Special hazards arising from the substance or mixture:

Combustion products may include carbon oxides or other toxic vapors. Thermal decomposition can lead to release of irritating gases and vapors. Avoid generating dust; fine dust dispersed in air in sufficient concentrations, and in the presence of an ignition source is a potential dust explosion hazard. SECTION 6: Accidental release measures

Personal precautions, protective equipment and emergency procedures:

Wear protective equipment. Use spark-proof tools and explosion-proof equipment. Avoid dust generation. Use respiratory protective device against the effects of fumes/dust/aerosol. Keep unprotected persons away. Ensure adequate ventilation.

Methods and material for containment and cleaning up:

If in a laboratory setting, follow Chemical Hygiene Plan procedures. Place into properly labeled containers for recovery or disposal. If necessary, use trained response staff/contractor. Dust deposits should not be allowed to accumulate on surfaces, as these may form an explosive mixture if they are released into the atmosphere in sufficient concentration. Avoid dispersal of dust in the air (i.e., clearing dust surfaces with compressed air). Collect solids in powder form using vacuum with (HEPA filter).

Precautions for safe handling:

Minimize dust generation and accumulation. Routine housekeeping should be instituted to ensure that dusts do not accumulate on surfaces. Dry powders can build static electricity charges when subjected to the friction of transfer and mixing operations. Do not eat, drink, smoke, or use personal products when handling chemical substances. Use only in well ventilated areas. Avoid contact with eyes, skin, and clothing. Wash hands after handling. Avoid dispersal of dust in the air (i.e., clearing dust surfaces with compressed air).

Conditions for safe storage, including any incompatibilities:

Keep in a dry place. Protect from freezing and physical damage. Provide ventilation for containers. Avoid storage near extreme heat, ignition sources or open flame. Store away from foodstuffs. Store away from oxidizing agents. Store in cool, dry conditions in well sealed containers. Keep container tightly sealed. Store with like hazards.
